Where applicable, please include confirmation of SEDOL codes, share class e.g. 'A', 'B', or 'C', and unit class e.g. 'Accumulation' or 'Income'. Unless otherwise instructed, where relevant we will purchase the clean share class version of the fund and 'accumulation' units. If 'Income' units are selected, the fund manager will be requested to pay all income as cash, which will be credited to your Dealing Account.

Please note that Utmost Wealth Solutions cannot permit fund-based commission to be paid to Investment Advisers, and any commission that would otherwise be available will be reinvested for the benefit of the policyholder.

Any instruction that is incomplete or requires clarification, may be delayed whilst we refer back to you. We are unable to backdate transactions resulting from any such delay.
